



Berks County Earth Day Committee For-Profit Exhibitor Contract

BERKS COUNTY EARTH DAY COMMITTEE (BCEDC) and

(also called Exhibitor), intending to be legally bound, agree as follows:

1. Exhibitor agrees to exhibit for attendees at the Berks County Earth Day Celebration, an event sponsored by BCEDC as follows:
Date: **Saturday April 21st, 2012**
Time: **11AM to 5PM**
Location: **Riverfront Park; Riverfront Drive, Reading, PA**
2. BCEDC responsibilities hereunder shall be:
 - a. BCEDC shall provide Exhibitor with booth space and one table. Any other component to be provided by Exhibitor or at some charge by BCEDC.
 - b. BCEDC represents that it has the necessary authority to permit Exhibitor to occupy said booth and site, which Exhibitor has been advised of prior to the execution of this agreement.
 - c. BCEDC shall conduct such promotions of the Earth Day Celebration and of Exhibitor's location as it, in its sole discretion, deems fit.
3. Exhibitor hereby agrees to indemnify and hold harmless Reading Parks and Recreation Department and Berks County Earth Day Committee, its officers, agents, servants, and employees, of and from all actions, causes of action, damages, suits or claims of any kind resulting from the service provided by Exhibitor under these agreements, its agents, servants or employees, whether negligent or non-negligent, or damage to Exhibitor's property.
4. The Exhibitor agrees to give BCEDC advance information on all sale items, raffles, giveaways, and other promotions to ensure that such actions are consistent with the purpose of this event. BCEDC reserves the right to reject applications of any Exhibitors based on available space. BCEDC reserves the right to disapprove actions or information inconsistent with the purposes of this function. The committee may ask any Exhibitor to remove item(s) from their display the day of the festival.
5. This agreement shall be mutually bindable on the parties hereto and shall not be assignable. Where the item "it" is used, it shall, referring to Exhibitor, include him, her, they, or them as applicable. This agreement contains the entire understanding between the parties hereto and any amendment hereof shall be in writing signed by both parties.
6. Exhibitor shall pay a non-refundable fee to help defray organizational expenses of BCEDC.
